## **Pharmacy Manpower Forum**

Today's technology and automation are evolving at an increasing rapid rate, and the state requirements for pharmacy practice have not kept pace – resulting in a perceived pharmacist shortage in many areas of the state and country. To discuss these and other issues and assure that California consumers have access to quality pharmacists' care, the board is providing another opportunity for interested parties to attend or provide written comments. This is a continuation of an information-gathering forum that was held by the Board of Pharmacy in September 1999, in Sacramento.

Among the topics to be discussed are: reciprocity of pharmacist licensure between California and other states, alteration of the pharmacist/technician ratio, direction of pharmacists to patient care functions (consultation, dosage forum modifications, profile review functions) and use of auxiliary personnel for non-discretionary tasks, pharmacists' control over working conditions and automation issues – central refill, pharmacist practice outside the pharmacy.
