Dear Board of Pharmacy,

I am a physician working in Indiana but also serving as medical director for a clinic in West Covina. I prescribe standard medications available in pharmacies anywhere. But I also prescribe, and depend on, specially compounded formulations from certain compounding pharmacies for specific needs not served by usual commercial preparations. You may not be aware that California has an impressive and reputable number of compounding pharmacies, several of which serve the needs of patients nationally. You may also not be aware that the United States excels other nations in the availability and the innovation of compounded preparations. Fortunately, compounding pharmacies today are adequately regulated for patient safety.

I urge you to promptly sign the FDA's MOU to allow 50% of compounds to be shipped across the country. It would serve no public interest to restrict this trade to 5%, but would significantly hamper access for tens of thousands of patients to safe and effective therapies.

I use compounding daily for patients.

We were able to get a family medication for worms that would have been 4K for a single dose for them (yes, you read that right) for \$40 total a few months back (yes, they had insurance)

We got a little girl compounded antibiotics that would cost her family several hundred a month (she needs to stay on continuously for kidney reflux) for around \$100 (also had insurance)

I compound creams for mysterious COVID rashes that do not respond to the really sad, basic creams we have available for conventional prescription.

And compounding allows me to very specially dial in thyroid hormones with individual T3/T4 combinations based on someone's labs and needs, rather than an archaic system of levothyroxine (T4) only.

Last year, our wonderful FDA took our (prescribers) ability to compound a fertility medication away. This was one I use ALL the time for men (yes, men) to fix their hormones. It allowed me to stimulate their own testosterone production, and even wean them off so they didn't need hormone replacement shots for the rest of their lives. That medication went from \$40/month, to thousands a month.

You may not need it now, but some day when you do, you won't have access to safe, compounded medications. They will have slowly disappeared while no one was looking.
