- California Code of Regulations section 1707.1 Duty to Maintain Medication Profiles.
- Business and Professions Code section 4332 Misdemeanor: failure or refusal to maintain or produce required drug or device records; willful production of false records.
- California Code of Regulations section 1718 Current inventory defined.

Angelita L. Quindoy, Jihan S. Soliven, and Pharmacy Link Corporation, were requested to appear at the Southern Compliance meeting as the result of an investigation that revealed during a routine inspection of Pharmacy Link Corporation, several violations of pharmacy law were observed. The Angelita L. Quindoy filled prescriptions faxed to the pharmacy from the patient, failed to document required information on prescriptions, and failed to document changes in prescriptions with the prescriber. Additionally Angelita L. Quindoy filled electronic prescriptions without verifying authenticity, and was not able to demonstrate compliance in conducting a patient medication history review prior to dispensing medications.
